Sub: Implementation of PRIASoft for the year 2011-2012.

Madam/Sir,

I must congratulate all the stakeholders of PRIASoft, especially Programme Officers and Computer Programmers of DRDA and Block for their commitment in implementing PRIASoft. Recognizing our sincere effort, Government of India felicitated Panchayati Raj Department, Government of Orissa with first prize on "e-Panchayat Puraskar-2011" in order to appreciate the excellent achievement of our State in implementation of Model Accounting System for Panchayats(MAS) and PRIASoft with prize money of Rs.50 lakh, a Trophy and a Certificate. With this National Level recognition, our field level functionaries should feel motivated and continue working with the same spirit for the implementation of PRIASoft in the year 2011-12.

It has been observed that at the beginning of the financial year 2011-12, many Districts, Blocks and Gram Panchayats are not uploading the data in PRIASoft on a regular basis. Most users are yet to close their day-book in PRIASoft as on 31st March, 2011, which needs to be addressed immediately. In this Department letter no.17-EG-25-1003/6413 dated 11.03.2011, it has been advised to compare the PRIASoft generated cash book with the official cashbook and communicate the discrepancies if any, to this Department for further modification of the report(s). Till date, we have not received any response from you.

Instructions have also been issued vide this department letter no. CFC-1/11-1977 dated 25.01.2011 for 100% verification of all vouchers including head of accounts of the Gram Panchayats by engaging Chartered Accountants Firms in your district.

However, it is imperative to run PRIASoft and PAMIS simultaneously till PRIASoft generated cash book is declared as the official cashbook for all PRIs by this department.
