

It has been decided to engage the VCEs to provide services of Gram Rojagar Sevaks (GRS). These GRS will have to be appointed at all e-grams. The VCEs already working at e-grams can function as GRS. If the VCEs are not available then you may recruit GRS following the guidelines of VCEs on the basis of the same qualifications. If it is not possible to engage GRS from the lot of existing VCES or following VCE guidelines, you may then select any suitable person with proper qualifications to function as GRS.

2. The GRS will have to give first priority to the NREGS work. They are also expected to provide services as VCE on the basis of the guidelines of the Panchayat department i.e. on a revenue sharing basis on 70:30 % . For the NREGS works the GRS will be paid a monthly honorarium of Rs. 1,000/- plus incentives. The formula of the incentives can be as follows:

“Number of person days generated divided by ten ( in Rupees)”

For example, if a Village Panchayat generates 6000 person days in a month, the GRS will get an incentive of Rs. 600/- for that month.

3. Please start selecting your team of GRS and provide them proper training. They can be engaged with effect from 1<sup>st</sup> April 2008.

4. As and when a CSC becomes functional a different arrangement is proposed. For Common Service Centre (CSC) villages the Service Centre Agency (SCA) can be compensated for the work done for NREGS on the basis of only incentive which is applicable for the GRS.

5. However, until CSCs become functional, GRS may be appointed also for the village panchayats which are covered under CSCs.

Detailed guidelines and instructions will follow.


